The following information was requested on 1 June 2023:

- 1. In the 21/22 financial year could you detail (i) how many claims for compensation you have paid out where the primary speciality has been recorded as HM Prison/Dental? (ii) the damages paid associated with these claims, (iii) the NHS costs paid, (iv) the claimant costs paid and (v) the total costs of damages and legal expenses.*
- 2. For the combined last five financial years (2017/18)(2018/19)(2019/20)(2020/21) and (2021/22) could you please break down the total number of these claims recorded as having taken place at HM Prison/Dental by the primary injury recorded? For each type of primary injury please state (i) the number of claims, (ii) the damages paid, (iii) the NHS costs paid (iv) the claimant costs paid and (v) the total costs of damages and legal expenses.*

Our Response

Thank you for your request for information. Please note we do **not** cover primary dental care.

NB: We have recently changed the way we report on our FOIs to align better with our published documents. Streamlining our reporting on FOIs with our annual published reports may mean a variation in snapshot dates. This means this data may not align with previous similar requests and it may not be possible for you to compare this information with a previous request. Please note claims notified/received and open are not guaranteed to be settled in the same year and can take many years to be concluded. Claims notified/received in any given year will often relate to incidents that have occurred many years prior. Due to the nature of clinical negligence claims and the level of investigation needed to bring them to a resolution, claims received and notified in a specific year may take years to settle.

The data shows variation in numbers of cases closed per year and costs attributed to those claims. The individual nature of claims received by NHS Resolution means they can vary significantly in value and any such fluctuations cannot be interpreted as trends.

Low Numbers

We have suppressed low figures as we believe that disclosure of information with this level of granularity is exempt under Section 40(2) by virtue of section 40(3A)(a) of the FOI Act, where disclosure to a member of the public would contravene one or more of the data protection principles. The data protection principles are set out in Article 5 of the General Data Protection Regulation. We take the view that it would not be fair or lawful (given the sensitive and confidential nature of the information held) to disclose such information, and any disclosure would therefore contravene the first data protection principle.

In some instances, the low numbers of claims (fewer than 5) in each category, the likelihood exists that individuals who are the subject of this information may be identified either from this information alone, or in combination with other available information. In addition to this, as this information is considered to be sensitive personal data (the data subjects' medical condition); NHS Resolution believes it has a greater responsibility to protect those individuals' identities, as disclosure could potentially cause damage and/or distress to those involved. Where we are in the territory of such small numbers in the attached, we have used a '#' symbol in the relevant field. You should still be able to see aggregate/total details for higher level fields containing this data.
