The following information was requested on 26 August 2024:

Please could you state how many cases you have settled in the total of the last eight financial years (2016/17) (2017/18) (2018/19) (2019/20) (2020/21) (2021/22) (2022/23) and (2023/24) under the clinical negligence scheme where the case has been brought against the NHS 111 service and the total compensation paid out for those claims?

Please also provide a breakdown of (i) both the injury code and (ii) the cause code for all of these successful claims in the last seven years.

NOTE: In relation to the year stated this should refer to the year in which the claim was paid NOT when the claim was lodged or when the incident took place.

Our Response to your specific request

We do cover claims arising from the NHS 111 service and the claim would be brought against the NHS organisation which operated the service. In most cases that would be NHS England, but if an ambulance trust operated the service it would fall on the trust responsible for the ambulance service.

Therefore, although NHS Resolution may hold some information relating to claims such as these, due to the way claims are recorded on our claims database, we will not be able to identify such specific cases. It might be helpful to explain that when claims are notified to NHS Resolution they are categorised against pre-defined cause, injury and speciality [codes](#). We do not have a code specifically for NHS 111. Therefore, while there may be information held in our records, we are not readily able to identify the relevant files by searching the database. To do so would involve a manual review of all cases to identify which ones relate to NHS 111. NHS Resolution receives thousands of claims each year.

Therefore, we estimate that the cost of complying with the request in its entirety would exceed the 'appropriate limit.' Section 12(1) of the FOIA is a provision which allows a public authority to refuse to comply with a request for information where the cost of compliance is estimated to exceed a set limit (known as the 'appropriate limit'). The

'appropriate limit' for NHS Resolution is £450. This equates to 18 hours of work at the rate of £25 per hour set out in the 'Fees Regulations'.

We estimate that it would take on average 10 minutes to locate, retrieve and extract the requested information from an individual file. It may therefore be the case that we would be able to examine only 108 files within 18 hours.

In addition, given the complexity of clinical negligence claims and their litigation, it is possible for a single electronic or paper-based file to contain hundreds of documents in a variety of formats.

Please also note even if we were able to carry out a review of 108 random files, we may not be able to provide you with the level of detail you require owing to Data Protection grounds.

We would need to suppress low numbers or any information that could possibly lead to the identification of claimants, patients or individuals where disclosure would breach the General Data Protection Regulation.
