### Committee Chairmen

#### Ian Crookall (Buckinghamshire)

Ian Crookall is a Solicitor and has held a number of senior professional posts with County Councils. He retired as the Chief Executive of Buckinghamshire County Council. Since then he has undertaken a range of work in the public sector for national organisations, such as the NHS and the Audit Commission. He has been a Chair of Regulatory panels for Health Care Regulators and chaired appeal panels for NHS England in relation to claims for Continuing Health Care. He has been a director of a locally based care provider of nursing, residential and domiciliary care.

#### Sheila Hewitt (Surrey)

Born in Pakistan, Sheila is an economics graduate from the London School of Economics and Political Science [LSE]. After an early career in finance in the City, she has held a number of non-executive posts during the past three decades. These have included serving on the Advertising Standards Authority, the Radio Authority [now part of [OFCOM], and the Legal Services Commission.

Sheila was the first Chairman of Surrey Heartlands NHS Trust when the internal market was introduced into the NHS. She has also chaired for nine years, Fitness to Practise hearings for the Medical Practitioners Tribunal Service, and seven years on the NMC Fitness to Practise Panel. Sheila is currently a Magistrate on the Surrey bench and a non legal member of the Asylum and Immigration Tribunal.

#### Muzamil Khan (West Midlands) – until 31 July 2019

Muzamil is currently a Tribunal Judge with the Asylum Support Tribunal and Social Security & Child Support Tribunal. He gained experience in practice dealing with immigration an asylum cases before going on to deal with regulatory law matters with the Law Society and Institute of Chartered Accountants. He was also Legal Services Manager with Refugee and Migrant Justice.

**Linda Lee** (Northamptonshire)

Linda Lee is a senior solicitor (qualified 24 years) having a leading role in applying and guiding development of the law in relation to professional regulation.

In private practice, Linda specialises in regulatory and disciplinary law at national law firm Radcliffes Le Brasseur, advising and assisting solicitors (in particular) and those dealing with them in an extremely complex and rapidly changing regulatory environment. She is a regular advocate before the Solicitors Disciplinary Tribunal. She frequently lectures and writes on legal and regulatory issues, is an editor of Cordery on Legal Services and a director of the Incorporated Council of Law Reporting. Linda is also Chair of the Solicitors Assistance Scheme, which provides advice and assistance to solicitors facing professional and personal difficulties. In her more public roles in and through the Law Society of England and Wales, and through other bodies, Linda is a leading voice for reform and improvement in regulatory law and practice and contributes extensively to the administration of justice.

She is a Past President of the Law Society of England and Wales (2010-2011), continues to be a Council Member and has held a number of key roles in the Society, including Chair of the Representation Board, Chair of the Legal Affairs and Policy Board, Chair of the Regulatory Affairs Board and is currently Chair of the of the Regulatory Processes Committee. She is also a member of the Society's Policy and Regulatory Affairs Committee and Access to Justice Committee. She is a former President and serving council member of the Medico-Legal Society. She recently stepped down after serving her full five-year term as a member of the Queen's Counsel Appointments Panel. She has previously been Chair of the Victims and Witness service in Northamptonshire. Linda is a Commissioner for the Criminal Cases Review Commission, the statutory body responsible for investigating alleged miscarriages of justice in England, Wales, and Northern Ireland.

As a separate strand in her legal life Linda holds a number of quasi-judicial offices; she is a legal chair for the General Medical Council, for the Taxation Disciplinary Board and for the Phone-paid Services Authority. She is a panel member for HS2's Need to Sell Scheme.

**Lucy Reid** (Conwy)

Lucy has worked in the NHS for nearly 20 years in both England and Wales and across both primary and secondary care. She is an Independent Board Member for Betsi Cadwaladr University Health Board and chairs the Quality and Safety Committee. She is a Tribunal Chair for the Medical Practitioners Tribunal Service and a Magistrate for the North Wales Family and Criminal Benches. Lucy has a Masters of Law in Healthcare Ethics and Law (Manchester University) with a particular interest in safety culture and professional regulation. She is also a Chartered Member of the Institute of Internal Auditors and a Certified Internal Auditor.

**Victoria Smith** (Monmouthshire)

Victoria began working in the law in 1998 as a Trainee Legal Advisor advising Magistrates on the law, practice and procedure in the Magistrates' Court. She qualified as a Solicitor in 1997 and worked in the Magistrates' Court as a Principal Legal Advisor advising Magistrates on the law until 2006. She left the Court service to join a leading national law firm as a practicing Solicitor which she combined with part time A level teaching. Victoria left private practice in 2016 to pursue a portfolio career, she is currently an Independent Member of the Ministry of Defence Service Complaints Panel, a lay panel member with the Statutory Regulators The General Pharmaceutical Council and the Health and Care Professions Council and is a professional advisor to the Department of Education on legal education

**Alan Tomlinson** (Lancashire)

With a degree in law from London university Alan Tomlinson joined a Manchester high street law firm qualifying as a solicitor in 1980. He moved to a similar practice in Wigan in 1989 and specialised in non contentious property work and probate. Alan retired from general practice in 2010 but remains on the roll of solicitors, working part time as a consultant. He has taken on many roles within the NHS starting with the Wigan FHSA in 1991, serving on various disciplinary tribunals and acting as an Oral Hearing Panel Chair of Pharmacy Appeals for NHS Resolution and its predecessors since 1992.

**Denise White** (Cheshire)

Denise spent 30 years working in the Probation Service in various positions, retiring in 2011 as Chief Executive of Derbyshire Probation Trust. For the last 12 years Denise has been a member of the Parole Board of England and Wales sitting as a Panel Chair.

**His Honour Graham White** (Hertfordshire) – until 31 July 2019

Graham White qualified as a Solicitor in 1965. After running a High Street General Practice with an emphasis on civil and family law, firstly as a sole practitioner and then in a two partner firm, he joined a Hertfordshire Criminal Practice as a consultant specialising in police station advice, and advocacy in both Magistrates and Crown Courts. He was one of the first 13 Solicitors in England and Wales to be awarded Rights of Audience in the Higher Courts in February 1994.

He served as a Member of the Council of the Law Society for 18 years and was Chair of its Housing and Criminal Law Committees and of the Solicitors Indemnity Fund Finance Committee. He sat regularly in the County Court as a Deputy District Judge from 1979 and also in both Crown and County Courts as an Assistant Recorder from 1992 and as a Recorder from 1996 until appointment as a Circuit Judge in February 2007. Currently sits as a Parole Board Judge and as Chairman of Disciplinary and Regulatory Committees of the Association of Chartered Certified Accountants.

**Jon Whitfield QC** (Hampshire)

Jon Whitfield is a senior barrister practising from Doughty Street Chambers in London. He specialises in cases involving offences of terrorism, murder and fraud and, issues of forensic science or mental health. He sits as a Judge in Mental Health Tribunals and is a Legal Assessor/Advisor in professional discipline and regulatory proceedings before the Medical Practitioners Tribunal Service and the General Pharmaceutical Council. Jon is a pension fund trustee responsible for @£10m of assets held on behalf of 140 investors and is a director of Phire Ltd a company he set up to procure best value in medical and support services for self employed legal practitioners. He is a trustee for The Kintampo Trust, a charity dedicated to training an entire generation of mental health practitioners in Ghana.

**Committee Members (Pharmacy)**

**Mike Beaman** (West Sussex) - BPharm, MSc, FRPharmS, MCPP, DipPresSci, FRSPH, FellowUH

Mike Beaman registered as a pharmacist in 1970 and has a wide experience in pharmacy practice, mainly in the NHS. In 1989 he became one of the first pharmacists to become a health authority medicines management and pharmacy lead and subsequently became a chief pharmacist in a Primary Care Trust in Hertfordshire prior to his retirement from the NHS in 2007. He now works in a free lance capacity as a pharmaceutical advisor with a particular interest in primary care including public health and medicines management. He

has been involved in a number of pharmacy organisations at both local and national level including the Guild of Healthcare Pharmacists, the College of Pharmacy Practice and the Royal Pharmaceutical Society. He was a founder member and first secretary of both the UK Psychiatric Pharmacists Association (1978) and the National Pharmaceutical Advisors Group(1991). He has been a CPPE tutor (1994-2010) and a reviewer for CHI, the Health Care Commission and latterly the Ombudsman's Office. He is a visiting fellow for the University of Hertfordshire and a member of the Pharmacy Oral Hearings Panel. He is also a member of the RPS Panel of Fellows.

**Phil Bratley** (West Yorkshire) - BScPharm, MSc, MRPharmS

Phil Bratley was for 30 years a community pharmacy proprietor. He has approximately 40 years experience on an LPC, firstly as a member, then as a development officer and then secretary. For over 10 years, he was Pharmaceutical Adviser for PCTs. He was previously a Non-Executive Director on a FHSA, an NVQ pharmacy technician assessor and a member and Chairman of a school Governing Body. Phil is currently a Lecturer to university Non-medical Independent Prescribers and member of the Pharmacy Appeal Committee (2005 Regulations).

**Fiona Castle** (Gloucestershire) - BSc MRPharmS

Fiona Castle registered as a pharmacist in 1990 and started her career in pharmaceutical production and packaging. She later transferred to Community Pharmacy and worked as a manager in both independently and large multiple owned pharmacies, becoming an LPC member in 2002, becoming an employed Local Pharmaceutical Committee Chief Officer in 2008. Fiona currently holds two district roles as a pharmacist in addition to her work as a panel member. She is the South West Regional Manager for CPPE (the Health Education England commissioned provider of continuing education to pharmacy professionals working in the NHS) and continues as the Chief Officer of Swindon and Wiltshire LPC

**Gail Curphey** (Isle of Man) - MRPharmS, Bsc, Dip Presc.Sci

Gail Curphey qualified as a Pharmacist from Manchester University in 1985, starting her career in hospital and then community pharmacy practice. She spent the last 22 years within Primary Care Organisations in Cheshire being responsible for the Medicines Management Team, supporting GP prescribing and the Community Pharmacy contract. Gail was a member of the English Pharmacy Board for its first 3 years and is a strong supporter of enhanced service delivery via Community pharmacists. Gail left the NHS, having attained the position of Associate Director of Medicines Management and Pharmacy, following the recent NHS re-organisations. She is now a self employed pharmacist consultant "with portfolio". As well as being an FHSAU Pharmacy Panel member, she is a GPhC Associate, CPPE tutor and undertakes varied project work.

**Paul McGorry** (East Yorkshire) BSc (Hons) MRPharmS FRSPH

Paul McGorry registered as a pharmacist in 1991. While his wide pharmacy practice experience is primarily within the community he also has also worked in GP prescribing support and joint working with hospital teams. He has held several senior management roles within a multiple setting. He has a particular interest in primary care and public health, while being a passionate supporter of enhanced service delivery by Community pharmacists within the evolving integrated NHS. He has been involved in a number of pharmacy organisations locally and regionally, a former pharmacy development group chairman, and has almost 20 years' experience on LPCs as an active member. As well as being an FHSAU Pharmacy Panel member he undertakes varied project work.

**Michael Smith** (Surrey) - BSc, MRPharmS

Michael Smith has served as a Panel Member since the inception of the Control of Entry Regulations. He was a community pharmacy proprietor until 2000 and then did occasional locum work until relinquishing his GPhC registration in 2010. He is currently a Borough Councilor and Chairman of the Planning Committee, a Secondary School Governor and a Governor of two NHS Foundation Trusts.

**Committee members (lay)**

**Paul Chapman** (Tyne & Wear)

Paul Chapman is a retired NHS Manager with over 20 years' experience in various aspects of Primary Care Development from quality management to the management of professional performance. Paul has extensive knowledge of the systems and processes involved with the determination of pharmacy applications and the general application of the Pharmacy regulations. Paul was a founder member of the Department of Health's Pharmacy Regulations and Guidance User Group serving on the group between 2005 and 2011. In 2013 Paul was appointed as a Lay Representative by Health Education North East and plays an active role in the assessment of doctors' progression through training, sitting as a member of Appeal Panels and participating in Quality Assurance visits of NHS Training Trusts.

**Stephen Chappell** (Derbyshire)

Stephen Chappell is a solicitor. He has spent the majority of his legal career in the Crown Prosecution Service (CPS). His last role in the CPS was as Chief Crown Prosecutor for CPS East Midlands. Since leaving the CPS in late 2015 Stephen has developed a portfolio career developing an interest in professional conduct issues. Stephen had worked for the Bar Standards Board (the regulatory arm of the Bar Council) and is a Legally Qualified Chair of Police Misconduct Hearings. In addition, Stephen has been appointed by the Lord Chancellor to be a lay committee member for the Leicestershire & Rutland Advisory Committee which appoints magistrates to the Bench. He is also a Chair of Valuation Tribunals dealing with council tax and non-domestic rates appeals.

**Penny Griffith** (Surrey)

Penny Griffith, MBA, is a widely experienced tribunal panellist in health care as well as other disciplines. She currently chairs Health and Care Professions Tribunals and sits on Nursing and Midwifery Council (NMC) Registration Appeals. She is a panelist on Tax Disciplinary Board committees and previously was a panellist for the Bar Tribunal and Adjudication Service. She chaired NMC professional hearings for eight years (2009 to 2017) as well as having been a director of two community charities.

**Madhu Kakar** (Merseyside)

Madhu Kakar has experience of legal and quasi-legal work. She has served as a Magistrate on Liverpool bench and as a member of fitness to practise panels for GMC and BACP. Madhu served as non-executive director of South Liverpool Primary Care and Merseyside Probation Trust and currently serves as member of PPG in local GP practice.

**Catharine Limm** (Worcestershire)

Catharine Limm is a former senior civil servant. Her career included policy work relating to health and social services and social security. In the mid-1990s she led an overhaul of social security decision making and appeals legislation. She was a non-executive director of an acute NHS Trust Board from 1997-1999. From 2007 until 2013 she was Clerk and Responsible Finance Officer for a large Parish Council in Worcestershire.

**Alan Lyon** (Manchester)

Alan retired from policing in April 2017 after three years leading the National Coordination of Prevent Counter Terrorism Policing, developing National Safeguarding measures. He has extensive experience working at senior level across Central Government Departments and with local stakeholders and partners, including communities. He is an experienced Senior Investigating Officer and throughout his career has been actively involved in safeguarding vulnerable children and adults. He advises on Counter Terrorism work Internationally and is an Associate of the Cabinet Office, Emergency Planning College and HM Inspectorate of Constabulary, Fire and Rescue Services.

**Steve Neale** (Buckinghamshire)

Stephen Neale spent nearly 27 years as a Police officer with Thames Valley Police, attaining the rank of Detective Chief Inspector and becoming a Home Office approved Senior Investigating Officer. Since retiring in 2006, he has spent 8 years with the Nursing and Midwifery Council as a regulatory Lay Chair for their Investigating Committee and currently sits as a Lay Member for the Architects Registration Board Professional Conduct Committee.

**Linda Summers** (West Yorkshire)

Linda Summers is a solicitor. She has worked in private practice, where she was a partner specialising in family law, and in the public sector, where she was a Regional Director for the Legal Services Commission. More recently, she has worked in professional regulation, initially as Assistant Director, Investigation, at the General Medical Council and currently as a lay panel member hearing fitness to practise cases at the Nursing and Midwifery Council and (as Chair) at the Health and Care Professions Council. She holds voluntary positions as a governor, and Chair of the Audit Committee, at a Sixth Form College, and as a public co-optee on the Scrutiny Panel of Kirklees Metropolitan Council.
