The following information was requested on 28 August 2020:

Key phrase: 'Testicular cancer'

The details of all claims pertaining to the diagnosis and management of testicular cancer within the specialty of Urology as practiced by Urologists, General surgeons and Paediatric surgeons, from 1998 to 2018 within the UK (England, Wales, Scotland, NI).

This should include, where possible:

- *Outcomes of the claims, both successful (closed with indemnity payment), and unsuccessful (closed without an indemnity payment)*
- *A description of the nature of the claim*
- *Where successful, the cost paid in damages*

Examples of the procedures / issues / conditions we are interested in are:

- *Testicular cancer*
- *Testicular lump*
- *Testicular tumour*
- *Radical orchidectomy*
- *Delayed/ incorrect diagnosis*
- *Recurrence of disease*
- *Infertility*
- *Testicular prosthesis problems*
- *Retroperitoneal lymph node dissection*

Our Response

Although NHS Resolution may hold some information relating to claims such as these, due to the way claims are recorded on our claims database, we will not be able to identify such specific cases. It might be helpful to explain that when claims are notified to NHS Resolution they are categorised against pre-defined cause, injury and speciality [codes](#), unfortunately *Testicular cancer* is not one of these. Therefore, while there may be information held in our records, we are not readily able to identify the relevant files by searching the database. To do so would involve a review of all cases to identify which ones relate to claims involving *Testicular cancer*. NHS Resolution receives thousands of claims each year.

We do have the following speciality: Urology

We could provide you with high level data relating to the specialty Urology and then capture claims where the injury is 'removal of testicle', however please note this may include reasons

other than testicular cancer. It could cover number of claims received for the specialty (Urology) in the relevant financial years; a breakdown by primary injury (removal of testicle); a breakdown by primary cause; numbers settled; numbers with no damages paid and numbers currently open. Please let us know if you would be interested in this data.

We would not be able to provide the other detailed information you have requested as the data is not captured in that way.

Therefore, we estimate that the cost of complying with the request in its entirety would exceed the 'appropriate limit'. Section 12(1) of the Freedom of Information Act 2000 is a provision which allows a public authority to refuse to comply with a request for information where the cost of compliance is estimated to exceed a set limit (known as the 'appropriate limit'). The 'appropriate limit' for NHS Resolution is £450. This equates to 18 hours of work at the rate of £25 per hour set out in the 'Fees Regulations'.

We estimate that it would take on average 10 minutes to locate, retrieve and extract the requested information from an individual file. It may therefore be the case that we would be able to examine only 108 files within 18 hours.

In addition, given the complexity of clinical negligence claims and their litigation, it is possible for a single electronic or paper-based file to contain hundreds of documents in a variety of formats.

Please also note even if we were able to carry out a review of 108 random files we may not be able to provide you with the level of detail you require owing to Data Protection grounds.

We would need to suppress low numbers or any information that could possibly lead to the identification of claimants, patients or individuals where disclosure would breach the General Data Protection Regulation.

Further to our obligations to provide advice and assistance, you may find it helpful to review the work of the [Getting It Right First Time team](#) with whom NHS Resolution has been working with to undertake in-depth analysis of our claims data. They have produced a number of [reports](#) from analysing our claims data which has been shared following approval of the confidentiality advisory group to the use of confidential patient information for this purpose.
